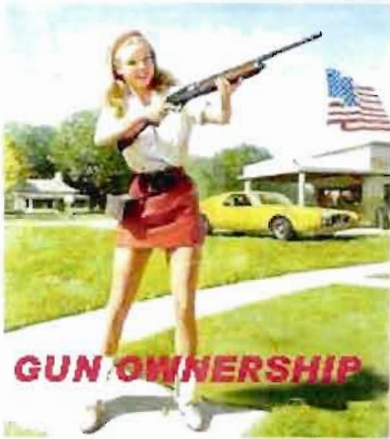

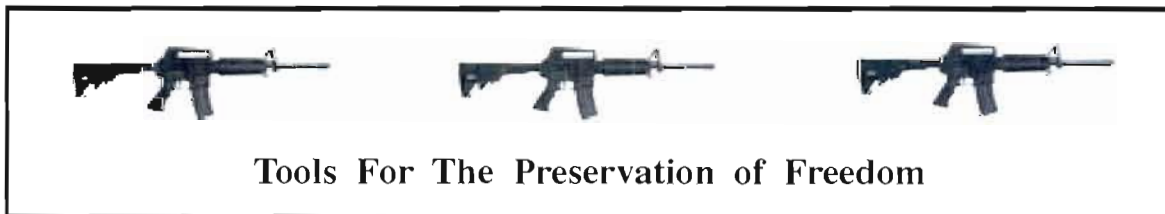

EXECUTIVE ORDER

PROMOTING INTERNATIONAL
REGULATORY COOPERATION

By the authority vested in me as President by the Constitution and the laws of the United States of America, and in order to promote international regulatory cooperation, it is hereby ordered as follows:
Section 1. Policy. Executive Order 13563 of January 18, 2011 (Improving Regulation and Regulatory Review), states that our regulatory system must protect public health, welfare, safety, and our environment while promoting economic growth, innovation, competitiveness, and

job creation. In an increasingly global economy, international regulatory cooperation, consistent with domestic law and prerogatives and U.S. trade policy, can be an important means of promoting the goals of Executive Order 13563.

EXECUTIVE ORDERS

“Executive orders are orders signed into law by U.S. Presidents, and are based on the proclamation (declaration) of national emergency (The 1973 Senate Report 93-549 formidably declares that, since March 1933, the United States has been in a state of declared emergency.)

“These specific orders grant strict government control over communications systems, power and fuels, farms and food resources, highways and transportation, air ports and aircraft, health, education and welfare, railroads, waterways and all public facilities. They provide for national registration of all persons to be administered by U.S. Postmasters, control of all civilians, including civilian work brigades, and the relocation of the American populous.

“All executive orders have been incorporated (combined) into one ‘master executive order’ (Executive Order (EO) 11490 signed by President Richard M. Nixon), which will activate all other Executive Orders.

“President William Jefferson Clinton signed into effect EO 12919, allowing the confiscation of all guns, ammunition, food, vehicles (including farm machinery), and control of all water and resources. This EO also includes civilian work brigades (without pay).

EOs are to be restricted to the management and control of federal government only and “no part of an executive order may direct the agencies to conduct illegal or unconstitutional activities,” according to the federal rules surrounding Executive Orders.

“Yes, our Constitution has been usurped. We the people no longer have a Republic. We are enslaved in the tyranny by an outlaw government. We are pawns of a one world, well ordered police state.

If Obama tries to issue an EO calling for more gun control, he will have a goodly number of County Sheriffs resisting. Former Arizona Sheriff Richard Mack has rightly stated, “Gun Control is illegal and it’s against the Constitution. He has stated that “What people don’t realize is that the Second Amendment was designed to protect us from the power of the federal government.”

Richard Mack, founder of Constitutional Sheriff and Peace Officers Association, says that at least 10 percent of America’s sheriffs are behind his organization and is growing. Pat Shannon, contributing editor of *American Free Press* (January 28, 2013) asked the question “... will the federal power still prevail over local law enforcement? After all, when in the 1960’s southern governors attempted to use National Guard forces to block school desegregation initiatives, the president promptly mobilized the Guard into the Army Reserve. This placed the commanders under federal [rather than state] authority, and threatened them with court marshal should they not carry out executive directives against their own people.

The same could happen in the case of new gun mandates. But Washington will surely have a harder time bullying the owners of more than 80 million guns in the United States and the sheriffs who support them.”

TYRANNY IN DELAWARE

Sheriff Jeff Christopher of Sussex County, Delaware, when he was elected to the office in 2010, thought he was handpicked by the people to represent them as the highest-ranking law officer in the county. Instead, he has found himself in the middle of a fight for the future of American law enforcement as a result of a nationwide effort to abolish the sheriff's office altogether.

It is one more example of federal and state governments ignoring the will of the people as well as state laws. In the case of Delaware, the state's own constitution stipulates that the office of the sheriff is a constitutionally created position just like the secretary of state and the attorney general. Delaware's Constitution states: "The sheriffs shall be conservators of the peace within the counties . . . in which they reside."

This time it is Delaware Attorney General Beau Biden, son of Vice President Joe Biden, sending out mandates to commissioners informing them that their sheriffs no longer have arrest powers. In an opinion released February 24, State Solicitor L.W. Lewis said that neither the state nor the common law grants arrest powers to the county sheriffs. It would appear that Lewis is a little confused. The office of sheriff was created more than a century before the official founding of the United States. Delaware's first sheriff took office in 1669.

Christopher tells *AMERICAN FREE PRESS* that the two administrations prior to his—as far back as 2000—began to notice a reduction in funding and the chipping away of powers of the office in general. “Now my deputies and I have been relieved of all arrest powers and can’t even make a traffic stop,” he said. “Delaware has only three counties. . . . The other two sheriffs . . . will not stand up with me” to prevent the elimination of county law enforcement, he said.

During an interview at the Las Vegas Sheriffs’ Conference in January, Christopher told AFP that the impotence of his office was brought home to him when he was hit in the eye and kicked by County Councilman Vance Phillips but was unable to arrest him.

Beau Biden’s questionable ruling against the longtime tradition of the sheriff being the highest ranking law enforcement officer in the county because of election by the people means the state’s usurpation of the office appears to be a forthcoming fact.

County spokesman Chip Guy announced, “*The opinion from the attorney general’s office reinforces what has long been the position of the county [that] Delaware sheriffs and their deputies do not have arrest powers and are not in the same vein as state police or municipal officers.*”

“*This bill makes the Delaware law clear that the county sheriffs and their deputies do not have arrest authority. Historically the sheriffs and deputies have and are not in the same vein as state police or municipal officers.*”

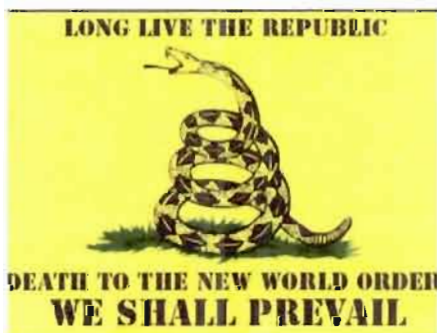

"Dana Safety Supply, a Southwestern distributor of weapons and accessories to police departments and civilians, announced that it is ceasing sale of semiautomatic rifles to civilians. Following the Sandy Hook Elementary School massacre of December 14, 2012, the Buckeye Firearms Association in Ohio has been offering free firearms training to educators to help them meet state requirements for obtaining a “concealed carry” permit. Over 900 teachers have applied to take the course, reports *The Hartford Courant*, a daily newspaper in Connecticut. Ohio law does not ban guns in schools, leaving it to each individual school board to define policy.
