## THE MEDIA GETS IT WRONG AGAIN: NRA MEMBERS OPPOSE SEMI-AUTO BAN

Just where did the “mainstream” media get the idea that the majority of NRA [National Rifle Association] members — at times cited as 74 percent — support a ban on semi-automatic firearms? Clearly not from actual members as NRA does not sell its lists. As a survey conducted by the NRA Institute for Legislative Action (NRA/ILA) found NRA members are nearly unanimously in opposition to that and on a wide range of related issues.

### Key findings:

- 89 percent oppose banning semi-automatic firearms, often mistakenly called “assault rifles.”
- 91 percent of NRA members support laws keeping firearms away from the mentally ill.
- 92 percent of NRA members oppose gun confiscation via mandatory buy-back laws.
- 93 percent oppose a law requiring gun owners to register with the federal government.
- 92 percent oppose a new federal law banning the sale of firearms between private citizens.

### NEW VIDEO CRUSHES MYTH ABOUT LARGE CAPACITY MAGAZINES

The video proves that determined shooters using smaller capacity magazines (clips) can fire just as fast, and in some cases even faster despite having to reload. The video demonstration, conducted under the supervision of Boone County, Indiana, Sheriff Ken Campbell and funded by ArmaLite, “throws cold water on anti-gunners who argue that magazine limitations are necessary to prevent mass shootings,” said Alan M. Gottlieb, Chairman of Citizens Committee for the Right to Keep and Bear Arms (CCRKBA).

Gottlieb explained, “Under Sheriff Campbell's supervision, two shooter (an experienced man and a novice female) are able to repeatedly fire 30-round shot strings at three targets, using 15, ten, and six-round magazines, all in under 30 seconds.”

The male demonstrator fired 30 rounds from a pistol, first with two 15-round magazines, in 20.64 seconds, then with three ten-rounders in 18.05 seconds and finally with five six-round magazines in 21.45 seconds. The woman fired the same magazine sequence, with two 15-round magazines in 22.9 seconds, three ten-rounders in 25.51 seconds and the final five six-round magazines in less time, 10.73 seconds.

In addition, the man then fires 20 rounds from an AR-15 rifle using a single magazine, in 12.16 seconds. He then fired 20 rounds using two 10-round magazines in less time, 10.73 seconds!

“Imposing magazine capacity limits creates a horribly false sense of security,” Gottlieb observed. “This video puts the lie to this politically motivated disarmament strategy.”

Sheriff Campbell notes in that video that, “One of the reasons that the magazine restrictions are being proposed is the perception that if the active shooter has fewer bullets in magazines he will have to reload sooner and this will create an opportunity for someone to tackle him during the reload.” In the demonstration, that notion is also proven false.

Magazine capacity limits offer no panacea to the rare mass shootings that have alarmed the country,” Gottlieb said. “It is time to stop this nonsense and expose limits as the monumental fraud they are.”

## MULTIMILLIONAIRE MICHAEL BLOOMBERG, MAYOR OF NEW YORK CITY, AND HIS RABID ANTI-GUN WARFARE

The election in Chicago to fill the vacant seat left by the resignation of Rep. Jesse Jackson Jr. has attracted attention from anti-gun forces.

CNN reported that anti-gun New York Mayor Michael Bloomberg and his political action committee have spent over \$1 million for ads criticizing candidate Debbie Havorson for her pro-gun stance. The ads call attention to Halverson's record supporting gun rights. The former congresswoman is seen as a leading candidate to fill the vacant seat.

### GUN COMPANIES LINING UP AGAINST NY

Some 20 plus firearms and accessories companies are lining up against the new anti-gun state law known as the SAFE ACT, announcing that they will not sell firearms to law enforcement agencies unless the same products and equipment can be sold to private citizens.

The sales boycott began with just a handful of companies in early February, but by the end of the month, it had surged to include firearms and accessories manufacturers such as Citizen Arms, Olympic Arms, York Arms, Midway USA, Lauer Custom Weaponry and about 70 other companies.

CCRKBA began keeping tabs on the growing boycott, noting that this may be the kind of action that gets the attention of lawmakers elsewhere.

The list also includes stalwarts as Barrett Rifles, J&G Sales, Top Gun Supply, NEMO Arms and Thunderbeast Arms.

Strum, Ruger released a form letter that can be copied by gun owners to be sent to Congress, arguing against any further restrictions on firearms ownership.

In addition, several large manufacturers are looking to move out of unfriendly states into gun friendly locations.

### OBAMA IGNORES LIVES SAVED BY FIREARMS

President Obama and Democrats were criticized by CCRBA for "packing" the audience for the President's State of the Union Address with crime victims in an attempt to push administration's gun ban agenda. Alan Gottlieb, chairman of CCRKBA stated, "President Obama has been claiming to want a balanced approach to solving the nation's gun violence problem. If that were true, he would have invited people who have defended themselves with firearms to be in the audience tonight as well. Instead, anti-gun Democrats are packing the House. When the President uses words like 'balance,' 'safety' and 'common sense', it's just a charade."

Gottlieb alluded to a recent poll by Quinnipiac University which showed few Americans (15 percent) considered changes in gun laws to be a top priority; rather, most (53 percent) felt the economy is still in recession, with 35 percent suggesting fixing the economy to be their top issue. Reuters reported the poll sampled the views of nearly 1,800 registered voters and had a margin of error of +/- two percent.

Gottlieb made note of the poll. "The President's policies are clearly in trouble, and he's using (the) State of the Union Address to grandstand for gun control while it is clear to a majority of Americans that the stagnating economy is far more important. **FORMER WHITE HOUSE CHIEF OF STAFF, NOW MAYOR OF  
CHICAGO, RAHM EMMANUEL ONCE SAID:  
“NEVER LET A GOOD CRISIS GO TO WASTE.”**

President Obama on December 21, 2012 issued a sweeping executive order banning the manufacture, sale and possession of **all** semi-automatic firearms in the U.S. Obama cited for his authority for the action a national state of emergency that has been in effect ever since Sept. 11, 2001, and renewed annually by both President George W. Bush and Obama ever since. He also cited portions of the Patriot Act that suspend certain civil rights that remain classified.

The tyrannical action by the president follows closely on the heels of the Newtown, Conn., massacre of 27 schoolchildren and teachers by Adam Lanza on December 12, 2013.

Obama vowed to present a detailed plan of action in January after naming Vice President Joe Biden to head a blue-ribbon panel including Cabinet members, law enforcement officials and various agencies of the government. Americans are no longer the masters of their government, as the founders intended. They have become subjects of their government, as most people in the world have been since the beginning of time. [Free men own guns, slaves don't.]

We are very, very, close to seeing some draconian action in Washington on this specific action – the unalienable freedom that secures all the rest of our constitutionally guarded liberties.

It may come in a more conventional form – with some legislators who formerly supported gun rights are yielding to the political winds and media distortion sweeping the country. But it more likely will happen in an unconventional and unexpected form – with an executive order. You might recall how Paul Begala, a top political adviser to former President Bill Clinton described executive orders: “Stroke of the pen, law of the land. Kinda cool.”

A real news story from *Reuters* published at 11:54 a.m., Wednesday, Dec. 19, 2012: “The Obama administration will consider executive actions and specific proposals for legislation as part of its gun policy response to the school massacre in Newtown, Connecticut, U.S. Attorney General Eric Holder said on Wednesday.” Holder, who has been a vocal proponent of a new ban on certain semiautomatic rifles, told reporters that a range of options need to be considered in the coming weeks.

“Those options will have to include a ‘strong and robust’ Bureau of Alcohol, Tobacco, Firearms and Explosives, the chronically under-funded agency that enforces federal gun laws”, he said. “It’s clear that we need to do more,” Holder said. He did not specifically call for a return of the assault weapon ban.”

## CITIZENS ACTION PROJECT



Some form of universal background check bill the greatest chance of making it through Congress, and through several state legislatures as well. Background checks sound good on the surface, and many gun owners have voiced their support.

**But are we talking about background checks or are we really talking about gun registration?** In every case, the proposals call for all firearm transfers to be conducted via a federally-licensed firearms dealer (FFL) or by local law enforcement. **This is really de facto gun registration.** FFL's are

required to enter ALL transfers in their bound book and have the buyer complete ATT Form 4473. Both the bound book and the 4473 contain a complete description of the buyer and the firearm being transferred. And that information is fully accessible by the ATT upon demand.

Can we count on local law enforcement conducting background checks to destroy data after a check is completed? It's not likely, given the penchant for retaining any and all data that comes into their possession. Some proposals specifically require retention.

**If they want to debate gun registration, then by all means do so. But call it registration. Don't try to sneak it under the guise of background checks.** Now is the time to contact your federal and state legislators and politely but firmly tell them you are opposed to gun registration in any form.

Gun registration may not be automatically lead to gun confiscation, but it is a necessary precursor to any effective confiscation program, as California is considering doing.

## THE NEW WELFARE MAP

Eleven states now have more residents dependent on government than they have people with jobs in the private sector. These are Ohio, Hawaii, Illinois, Kentucky, South Carolina, New York, Maine, Alabama, California, Mississippi, and New Mexico.

Last month, the Senate Budget Committee reported that in 2011, between food stamps, housing, child-care, Medicaid and other benefits, the average U.S. household below the poverty line received \$168 a day in government support.

To put this in perspective, the median household income in America is just over \$50,000, which averages out to \$137.13 a day. Welfare now pays the equivalent of \$30 an hour for a 40-hour week, while the average job pays \$25 an hour. (*American Free Press* 3/25/13).
