SEN. FEINSTEIN WRONG AGAIN

Democrat Senator Diane Feinstein of California says she knows all about the Second Amendment, claiming you don't need a gun for deer hunting like the rifle she is holding. However, the Second amendment is not about hunting; it is about protection against government tyranny. The militia mentioned in the Second Amendment was the able-bodied citizen:

"I ask, sir, what is the militia? It is the whole people..., to disarm the people, that is the best and most effective way to enslave them."

Sen. Feinstein, not only is ignorant or subversive to the Second Amendment, but she is ignorant of rules of gun safety: Note her finger on the trigger. You don't put your finger on the trigger until you intend to fire the gun. Sen. Feinstein, one of the nations worst gun grabbers, wants to take away your guns, but she has a conceal carry weapons permit. Hypocrite!

FEINSTEIN'S SEMI-AUTOMATIC BAN

The first ban on semi-automatic rifles (1994), under the Bill Clinton administration, passed with an expiration date in order to be passed. That expired ban proved that it did not prevent crimes like the Columbine High School attack. FBI crime data reveals that rifles of any kind are used only in a fraction of violent crimes annually, yet Democrats on the Judiciary Committee have allowed this legislative travesty to move forward.

The most recent FBI data (2011) shows there were 323 homicides committed with rifles out of 12,664 murders, which included 8,583 that were committed with firearms. Yet, Sen. Feinstein demonizes certain firearms, calling them "*assault weapons*." Such scapegoat strategy by politicians has allowed the broken justice system to release violent offenders back on the street while disarming their potential victims. Alan Gottlieb, Chairman of the Citizens Right to Keep and Bear Arms (CCKRBA), said: "*By focusing their energy on disarming law-abiding citizens, politicians like Feinstein are perpetuating a myth that firearms cause crime. That's as foolish as believing that cars cause drunk driving.*" Gottlieb stated, "*Instead of banning the most popular fire arms in the country, we need to ban politicians who assault our rights. We are appalled and disappointed that Sen. Feinstein and her cronies have advanced this measure, which demonizes firearms that are used thousands of times each year to protect the lives and property from criminal attack.*"

Sen. Feinstein has long coveted a ban on semi-automatic rifles. Several years ago, Sen. Feinstein confessed during a CBS interview that if she could have mustered the votes, she would have pushed through legislation forcing "*Mr. and Mrs. America*" to "*give them up.*"

Clinton's ban expired in 2004. Feinstein's bill differs from the expired ban in that her legislation would make the ban permanent and also ban magazines that hold more than ten cartridges. Gottlieb says, "*Public policy and constitutional rights should not be subject to the whims of gun prohibitionists who are quick to exploit the crimes committed by a few crazy people, in order to advance their agenda of public disarmament.*"

SENATE VOTE ON ROLE OF UN TREATY AND RIGHT TO BEAR ARMS

On March 25, 2013, the U.S. Senate voted 53 to 46 on an amendment offered by Senator Jim Inhofe (R-OK) that affirmed that no treaty would supersede the U.S. Constitution. The vote came just days before the United Nations concluded the Arms Trade Treaty negotiations.

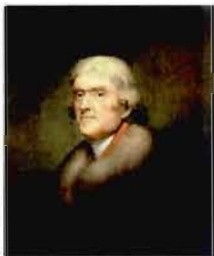

According to Syracuse University's Transactional Records Access Clearinghouse (TRAC) analysis of federal data, the Eastern District of New York where New York City is located, Los Angeles home district and Northern Illinois, Chicago's federal court circuit, are cities ranked 88th, 89th and 90th out of ninety districts in prosecutions of federal weapons crimes on a per capita basis.

UNITED NATIONS CONFISCATION OF PRIVATE WEAPONS

Faith & Freedom Sentinel has, in past issues, exposed the Communist takeover of the Democratic Party (Progressives) and the Republican Party (Trotskyite - Neoconservatives, (predated by the subversive O.S.S. (Office of Strategic Services). The subversive leaders have now advocated ceding the people's rights to the United Nations through the Small Arms Trade Treaty, which includes, among other despicable mandates, that all nations create:

- 1) a registry of gun owners, manufacturers, and traders.
- 2) a mechanism that would prevent private individuals from purchasing ammunition.

The Second Amendment, as with all the enumerated rights included in the Bill of Rights, is a lawful contract not subject to imprecriptibility.

THE U.N. ARMS TRADE TREATY

The U.N. Arms Trade Treaty, backed by President Obama, is a travesty and terrorist attack upon the Constitution of the United States of America. The rights enumerated in its Bill of Rights are God-given. The

Declaration of Independence states: “We hold these truths to be self-evident: That all men are created equal; that they are endowed by their Creator with certain unalienable rights,....” Contrawise, the United Nation’s 1948 Universal Declaration of Human Rights proclaims the rights “are granted,” not by God, but by a “constitution or by law.” The UN’s 1966 International Covenant on Civil and Political Rights enumerates its rights without mention of God as their source, and then discusses “restrictions... provided by law.”

The U.S. Constitution’s Bill of Rights, Amendment I, begins with the words: “Congress shall make no law respecting....” followed by the Second Amendment. If the United States submits to the UN Arms Trade Treaty, America will soon have no rights, not even the “right to keep and bear arms,” our God-given right to self-defense against oppressors, including a tyrannical federal/state government or international UN oppressive, tyrannical “peace-keeping force.”

Founders of the UN:

The members of the planning commission to create the charter (constitution) for the UN were members of the Council on Foreign Relations (CFR), a private, tax-exempt, non-governmental organization, incorporated in 1921. Some were both CFR and Communists. The ultimate aim of the CFR is basically the same as that of Communism, to create a world socialist dictatorship. This editor's, "The Report On The United Nations" gives their names. The CFR, with good reason, is called the "secret government," the "invisible government," our shadow government," the "hidden government," and "America's unelected rulers."

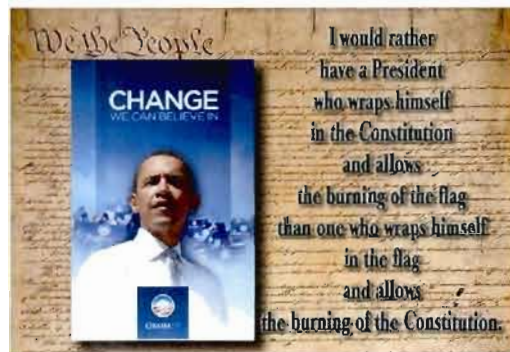
