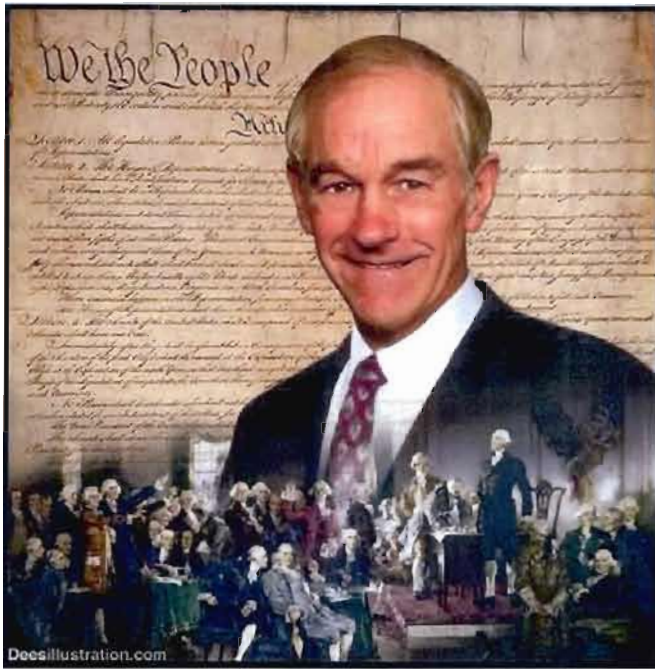

CONSTITUTION DAY

September 17 is designated Constitution Day in recognition of the anniversary of the signing of the Constitution of the United States of America.

Our founding fathers adopted the Constitution of the United States of America in 1787 to secure our God given unalienable rights. Note below how far we have apostatized from that document of freedom, and how the nation has repudiated the God given and unalienable rights enumerated in the Constitution.

1. **The Constitution** does not allow the Supreme Court to make law.
2. **The Constitution** does not allow the President to make law.
3. **The Constitution** gives the federal government no power in the field of education.
4. **The Constitution** gives no government authorization for foreign aid.
5. **The Constitution** requires a President to be a natural born citizen (not an immigrant who became a citizen).
6. **The Constitution** does not give the federal government power to create a bank (F.R.S.; I.M.F.).
7. **The Constitution** does not allow treaty law to supersede the Constitution.
8. **The Constitution** does not allow the President alone to take the nation to war.
9. **The Constitution** specifies only three crimes, treason, bribery and piracy.
10. **The Constitution** does not provide for a standing army. Article I, Section 8 says that the Congress can raise an army but "no appropriation of money" to fund it shall be for longer than two years. It goes on to say however that, Congress can provide for a navy without that same restriction regarding funding. Why? Because the men who wrote the Constitution feared the possibility that a standing army housed within the territory of the nation might arise and seek to take power. But they did not fear that a navy would try to do that because a navy and its weaponry did not reside within the nation, only at sea or coastal seaports.
11. **The Constitution** nowhere mentions the word "democracy." The U.S.A. is a Constitutional Republic, not a democracy. Democracy (mobocracy) is rule by the majority which can vote away freedom and property. Under a Constitutional Republic the "law" or government cannot touch a minority of even one person in his life, liberty or property except by perversion of the law or administration. In a Constitutional Republic, our God given and unalienable rights are not subject to majority rule or government edict. In a **humanistic-Marxist philosophy**, our "rights are derived from the State, so that the State has the legitimate authority to end our rights. The **Christian-American philosophy** is that, "all rights are derived from God." In a Constitutional Republic, a **free nation**, the people are responsible for their own welfare. In a **slave nation** (Democracy -socialism) that responsibility is turned over to the government.

BENGHAZI: MURDER AND TREASON?

Barack Obama and Hillary Clinton refused to send troops to help four Americans to Benghazi, denying them back-up. (Murder! Treason!) The Pentagon was aware of the attack. The battle raged for seven hours. About a half an hour after the attack started there was a drone overhead monitoring the attack. Diplomatic security official, Charlene Lamb was monitoring the audio feed of the attack in real time in Wash-

ington. Asked to explain the inaction on the part of the Pentagon, Panetta said, *"The basic principle is you don't deploy forces into harm's way without knowing what's going on, without having some real-time information about what's taking place."* Contrary to Panetta's claim, we know with certainty that there was real-time information coming into Washington and the Pentagon during the attack.

On August 2, Ambassador Stevens sent a cable requesting 11 additional body guards, noting *"Host nation security support is lacking and cannot be depended on to provide a safe and secure environment for the diplomatic mission of outreach,"* *The Wall Street Journal* reported on October 10 that the Administration removed a well armed, 16 member, security detail from Libya in August, to be replaced by the Libyan security personnel that Ambassador Stevens had just told them could not be relied upon.

Egyptian security officials said murdered U.S. Ambassador Christopher Stevens played a central role in arming and recruiting rebels to fight Syrian President Bashar al-Assad. In November 2012, Middle Eastern security sources further described both the U.S. mission and nearby CIA annex in Benghazi as an intelligence and planning center for U.S. aid to the rebels, which included weapons shipments being coordinated with Turkey, Saudi Arabia and Qatar. Many rebel fighters are openly members of terrorist organizations, including al-Qaida. The information may help determine what motivated the deadly attacks in Benghazi. Gun-running to oust a foreign government is an act of war, and the gun-running had not been authorized by Congress (which has the exclusive power over war under Article I, Section 8 of the U.S. Constitution).

Stevens had a presence at the CIA annex before the Special Mission Benghazi Compound was created. Stevens was at the CIA annex in the summer of 2011, shortly before the CIA created the Special Mission Benghazi Compound, the facility that eventually became the diplomatic front for the CIA's operations in Benghazi. Stevens was not, at the time, Ambassador to Libya. At the time Stevens was the Special Representative to the Libyan Rebel-Alliance. According to the *New York Times*, Stevens had even dealt with applications coming from U.S. weapons dealers requesting licenses to sell arms to Libyan insurgents.

Former Republican presidential candidate Ron Paul has stated, *"The Islamic radicals who attacked Benghazi were the same people let loose by the US-led attack on Libya. They were the rebels on whose behalf the US overthrew the Libyan government. Ambassador Stevens was slain by the same Islamic radicals he personally assisted just over one year earlier."* The former congressman added: *"The real lesson of Benghazi will not be learned because neither Republicans nor Democrats want to hear it. But it is our interventionist foreign policy and its unintended consequences that have created these problems, including the attack and murder of Ambassador Stevens. The disputed talking points and White House whitewashing are just a sideshow."*

John Adams once wrote that, *"I expressly say that Congress is not a representative body but a diplomatic body, a collection of ambassadors from thirteen sovereign States."* Each state had its own political and cultural life and each was "sovereign."

Robert Yates, writing as Brutus in 1787, observed that *"In a republic, the manners, sentiments, and interests of the people should be similar. If this not be the case, there will be a constant clashing of opinions; and the representatives of one part will be continually striving against those of the other."*

States' rights and the Tenth Amendment to the Constitution were intended to protect this cultural distinctiveness. This is why the three most powerful States in 1788, Virginia in the South, New York in the mid-Atlantic, and Massachusetts in the North, considered an explicit recognition of States' rights an essential condition for ratification of the Constitution.

Of course, those who champion States' rights and decentralization are often accused of preferring "Balkanization" over the blessings and security of "one nation." If the federal government followed its limited, constituted authority, such "Balkanization" would not be necessary, but hardly anyone in the founding generation would have agreed to a system of central government that currently exists in the United States.

NSA FORMING A NATIONAL GUN REGISTRY?

The NSA has already been caught spying and collecting millions of American's phone records and more. But now a group of 26 bipartisan Senators recently sent the NSA a letter demanding they reveal the scope on how far their surveillance activities go. Fat chance of finding out!

The 26 Senators suggest the NSA could be retaining firearm sales records to form a national gun registry with a national database of everyone's firearms, where they are, what types they have, and how many they have.

We must demand that Congress investigate the NSA's surveillance activities of millions of American people. In a free nation, neither the NSA nor any other agency of the U.S. Government EVER needs a national gun registry!

DEMAND CONGRESS STOP ANY NSA NATIONAL GUN REGISTRY!

Gun dealers are forced to hand over firearm sales records to the ATF who are then **supposed to** destroy the records after a certain number of years and we are expected to be gullible enough to believe ATF simply destroys all trace of those gun records! With the track record of the Obama Administration of scandals, anti-gun campaigns and constant cover ups, only a fool would not be suspicious of our Government forming a national gun registry, especially when both the Democrat and Republican parties support the agenda for world government that requires disarming all means of resistance.

Under section 215 of the subversive Patriot Act, the U.S. government is usurping "authority" to abuse our personal privacy rights by collecting information on credit card purchases, pharmacy records, medical records, financial records, firearm sales records, financial information, library records, and records of book and movie purchases.

Maintaining gun owner databases is the prelude to confiscate firearms of citizens.

Brian Phillips, a spokesperson for Senator Mike Lee has stated, *"In this country, the government can't just monitor your constitutionally protected activities--like gun ownership--just because it wants to. The justification that, 'if you're not doing anything wrong, you don't have to worry about it,' turns us into a police state very quickly. That's why Congress is right to see broad oversight of the NSA's data collection programs."*

Charley Reese, News columnist (Feb. 2, 1999 in the *Conservative Chronicle*) warned that *"... when government seeks to disarm the citizens, it plainly intends to do away their freedom. No movement in America should alarm Americans as the gun control movement because its true aim has nothing to do with crime, but everything to do with disarming honest, decent Americans."*

The Second Amendment was written to protect American citizens from a tyrannical take over by our government. The first step in a Tyrannical take over is disarming all of its citizens. This is made easier if the Government has a record of every firearm purchased by its citizens. Therefore, our representatives are absolutely right for seeking oversight into the NSA's spying programs.

The fact that the NSA is being suspected of creating a national gun registry combined with the pressure the Obama Administration has put on anti-gun legislation raises some significant questions about what our government wants to do with its citizen's firearms.

Louis Freeh, FBI Director approved by Bill Clinton. At his U.S. Senate Confirmation Hearings, July 30, 1993, Freeh declared, *"The strongest gun legislation...I will enforce diligently and exhaustively."*

FINLAND'S INTERIOR MINISTER

Finland's Interior Minister has sparked uproar by sharply criticizing the country's liberal abortion laws. In a July 6 [2013] speech to a Lutheran gathering in Kankaapaa in southwestern Finland, Interior Minister Päivi Räsänen lamented that animals have more protection in Finland than unborn human babies. Citing Acts 5:29 [*"Then Peter and the other apostles answered and said, We ought to obey God rather than men."*], she also noted that one may face situations "*...where we must weigh our actions, whether we are ready to go against public opinion, peer pressure and even law if these contradict the Word of God.*"

The archbishop and two bishops of the Evangelical Lutheran Church of Finland wasted no time in declaring that the Interior Minister does not speak for the [Lutheran] church. In her speech, Mrs. Räsänen noted that Finnish law provides that animals being slaughtered must be killed painlessly, but that Finnish politicians will not even discuss the pain that fetuses can feel during abortion. Räsänen, a medical doctor, says that a fetus at the age which Finland allows abortion is not a piece of tissue without emotion but an individual who can feel pain.

Minister of the Interior Päivi Räsänen is in charge of the Ministry of the Interior. She handles matters covered by the Police Department, Department for Rescue Services, Border Guard Department and the Migration Department.

Mrs. Räsänen also deals with matters covered by the units directly under the Permanent Secretary, and church affairs, which fall under the Ministry of Education and Culture.

Editor's Note: Church leaders defy God on the abortion issue as do the liberal politicians. That this continues as national policy with the Lutheran church leaders approval should warrant an outcry from the citizens of Finland and particularly an outcry of rage from members of the Evangelical Lutheran Church of Finland. The Lutheran and other protestant churches have long lost their protests against heresy and corruption in high places. Drowning in the cesspool of apostasy and the evils it spawns, the members of these so called churches rebel against God and his command to be separate. The same can be said of members of mainline "churches" world-wide, including those in the United States.

The problem of apostasy within "Christendom" is an unregenerate membership from pulpit to pew. The problem is one of rebellion against the Word of God, disobedience against God's commands regarding the doctrine (teaching) on separation.
