RETIRED ARMY OFFICER WARNS: DHS PREPARING FOR WAR AGAINST AMERICAN CITIZENS

March 23, 2013

On Saturday, Terry M. Hestilow, a retired United States Army Captain from Fort Worth, Texas, posted a letter on Facebook that he wrote to Sen. John Cornyn, R-Texas, warning that the Department of Homeland Security is preparing to go to war with the citizens of the United States.

"It is with gravest concern that I write to you today concerning the recent appropriation of weapons by the Department of Homeland Security (DHS) that can only be understood as a bold threat of war by that agency, and the Obama administration, against the citizens of the United States of America," his letter began.

The retired officer expressed deep concerns over "recent purchases of almost 3,000 mine-resistant ambush-protected (MRAP) armored personnel carriers, 1.6 billion rounds of ammunition (with associated weapons), and other weapons systems."

Capt. Hestilow added a statement that Barack Obama made during his 2008 campaign.

"We cannot continue to rely only on our military in order to achieve the national security objectives that we've set. We've gotta (sic) have a civilian national security force that's just as powerful, just as strong, just as well funded [as the United States military]," he said.

He also accused the administration of "deliberately defunding, overextending, and hollowing the Department of Defense," which he said is the "only legitimate agency" with the mission of conducting combat operations.

In his letter, Capt. Hestilow called on Congress to demand that the DHS surrender their weapons systems to the Defense Department. He also accused the DHS of enforcing the "tyrannical acts of this president" and said lawmakers should dissolve the agency "as soon as possible."

"One needs only to look to the rise of Adolf Hitler, and his associated DHS organizations, the SA and the SS, of 1932-1934, to see the outcome of allowing an agency of government this kind of control over the free citizens of a nation," he added.

Capt. Hestilow said that Americans cannot "be so naïve" as to think that what happened in Germany cannot happen here.

Earlier in the week, Capt. Hestilow asked his Facebook followers who the DHS intends to kill with the weapons and ammunition that it has recently purchased.

"Short answer," he wrote. "You and me! Anyone they think is standing in their way to impose a new Marxist government! Anyone who stands for the U.S. Constitution!"

"If I live and still have a page to speak out on later this week, I will discuss a proper Constitutional response in a couple of days. Standby. Out," he wrote on Thursday.

Capt. Hestilow ended his strongly-worded letter with a simple declaration: "***We refuse to surrender our Constitution or our nation!***"

'GUN CONTROL PLAYBOOK' EXPOSED



"Preventing Gun Violence Through Effective Messaging," an 80-page document of information about how gun prohibitionists will frame their arguments was uncovered by Alan Gottlieb, Chairman of Citizens committee for the Right to Keep and Bear Arms (CCRKBA).

Inside the guide are tips on everything from using effective rhetoric to dividing gun owners. It was prepared by consulting experts from three different Washington, D.C.-based firms who have considerable experience.

The guide was partly prepared by a principle member of the firm of Greenburg Quinlan Rosner (GQR), which also has offices in London, and Buenos Aries. Among GQR's clients are the Mayors Against Illegal Guns, the Joyce Foundation, several state education associations, Defenders of Wildlife, National Public Radio and the Sierra Club.

The guide addresses Stand Your Ground laws and counsels the use of provocative substitute phrases including "Shoot First" and "Kill at Will" when discussing these statutes. The argument is that these terms are "more accurate and persuasive."

The guide's major talking points have apparently already been used to influence the debate over gun laws in Washington State Legislature earlier this year, and could also become part of the rhetoric of an anti-gun initiative campaign. Those talking points were revealed in a memo that was attached to an e-mail recovered in a public records request to the King County, Washington executive's office relating to that office's involvement with a controversial gun buyback in Seattle. Those records were recovered thanks to the state's public records law, which was also used to obtain records from the City of Seattle.

The document also identifies terms that should be avoided in public debate, among them the term "duty to retreat," noting that the term may be an established legal principle, but it always conveys a weakness and is "hard to defend."

Another key is that anti-gunners are counseled to frame their arguments around personal and emotional messages.

Gottlieb is convinced the gun control guide was never meant for general circulation. It is a carefully written political strategy document that underscores the effectiveness of emotion over facts and statistics in the gun control debate.

Likewise, the memo that was recovered in relation to the Washington State firearms situation also stressed semantics over substance, and recommended that gun prohibitionists disguise their true intent by using such phrases as "stronger laws" rather than "stricter laws," and "preventing gun violence" rather than "gun control."

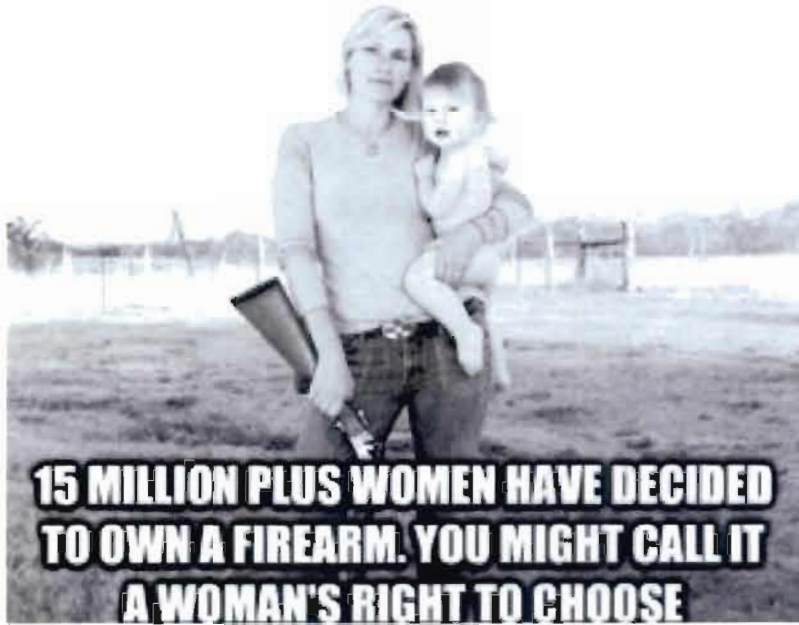
That last advice revealed perhaps more than the guide's authors intended. The title of their play-book "Preventing Gun Violence Through Effective Messaging," could easily be called "Gun Control Through Effective Messaging."

MOM PROTECTS HOME WITH GUN TWICE IN FOUR MONTHS

Toledo, Ohio mom, Betty Collins protected her household, not once, but twice in the last four months.

Four months ago, about five in the morning, 31-year old Kyle Caldwell began kicking at the front door of Betty Collins home in an attempt to break in. Betty yelled for the attacker to leave because she had a gun and it was loaded. He didn't heed her advice until Betty opened the door herself and the intruder found himself facing the

barrel of the loaded .357. Realizing the danger he was in, the man did as he was told and laid face down and waited for police to arrive.

Just four short months later, at around 1:00 am on Sunday morning, Betty awoke to hear chains rattling on her front porch. She opened the front door and confronted 21-year old Thomas Lee Johnson trying to steal one of her family's bicycles which were chained up on the porch. She told him to stop and to leave, but he continued trying to get the chain off the bike. At that point she retrieved her gun and commanded the young man to lay down on the ground. The would-be thief obeyed her command. Police arrested him shortly thereafter, and he will be brought up on misdemeanor charges.

It wasn't until she was prepared to use her .357 that they began to take her seriously. Without her gun, things may have ended very differently for Betty and her family.

It is time that people realize that they themselves are responsible for their own safety. *Faith & Freedom Sentinel* has cited court decisions declaring that the police are not responsible for the safety of citizens. The police catch criminals or people who have already committed criminal acts and less frequently do they prevent crime. The best way to prevent crime is for law abiding citizens to stop acts of crime before they happen. Way to go, Betty Collins!

In 1929, the Soviet Union established gun control. From 1929 to 1935, about 20 million dissidents, unable to defend themselves, were rounded up and exterminated.

In 1911, Turkey established gun control. From 1915 to 1917, 1.5 million Armenians, unable to defend themselves, were rounded up and exterminated.

China established gun control **in 1935**. From 1948 to 1952, 20 million dissidents, unable to defend themselves, were rounded up and exterminated.

Germany established gun control **in 1938**. From 1939 to 1945, 20 million Jews and others who were unable to defend themselves were rounded up and exterminated.

Cambodia established gun control **in 1956**. From 1975 to 1977, one million 'educated' people, unable to defend themselves, were rounded up and exterminated.

Guatemala established gun control **in 1964**. From 1964 to 1981, 100,000 Mayan Indians, unable to defend themselves, were rounded up and exterminated.

Uganda established gun control **in 1970**. From 1971 to 1979, 300,000 "Christians," unable to defend themselves, were rounded up and exterminated.

Defenseless people rounded up and exterminated in the 20th Century because of gun control: 56 million.

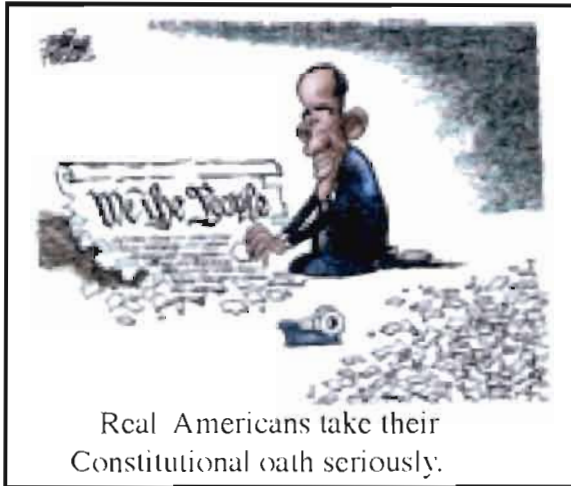
TWO FATAL DEMOCRAT ERRORS IN OBAMA CARE

OBAMA'S ASSAULT ON LIBERTY AND AMERICA'S CONSTITUTION



The Obama administration is hiring 16,000 new IRS agents to enforce ObamaCare and creating 159 brand new government agencies to administer ObamaCare.

President Obama is using ObamaCare to force doctors and hospitals to investigate which parents own guns. Government can then track and monitor law-abiding gun owners, stripping away Second Amendment Constitutional rights. It is also an assault on Fifth Amendment rights.

Barack Obama, when he was an Illinois State Senator in 2001, made this statement in a radio interview concerning the U.S. Constitution, *“The Constitution reflected the fundamental flaw of this country that*

continues today.” In that interview, he also said the problem with the Constitution is that it’s a *“charter of liberties.”* The big concern in that interview was that the Constitution does not give the federal government enough power.

President Obama brazenly lied to Congress and the American people about the true cost of ObamaCare. In a televised address to the nation, Obama told America and Congress that ObamaCare would cost less than \$1 TRILLION over ten years. We now know that ObamaCare will cost at least \$10 TRILLION when you factor in the costs to states, the cost of the “Individual Mandate,” the cost of increased health insurance premiums, the \$716 billion ObamaCare steals from Medicare, the 21 new taxes and tax increases contained in ObamaCare, and the increased cost of business of complying with ObamaCare mandates. Corporate CEO’s receive long prison sentences for fraud if they knowingly provide false costs and financial forecasts to investors. ObamaCare (which passed into law by a single vote in the Senate) clearly would not have passed if Congress had understood the true cost of ObamaCare.

When selling ObamaCare (deceptively misnamed “the Patient Protection and Affordable Care Act of 2010”) to the nation, President Obama claimed that the annual health insurance for a family would drop by \$2,500 by the end of his first term. Instead, the cheapest health insurance plan available in 2016 for a family will cost \$20,000 for the year. (Source: **Faith & Freedom Coalition.**)

The U.S. Supreme Court ruled in 2012 that the federal government has no authority under the Constitution to compel the states to pay for or administer ObamaCare. Texas is now the largest state to refuse to participate in ObamaCare, thanks to the leadership of Governor Rick Perry. At least 20 governors so far have indicated that they will refuse to use any state taxpayer money on ObamaCare. Experts say that if even just half the governors refuse to pay for ObamaCare, the program becomes unworkable and is effectively dead.

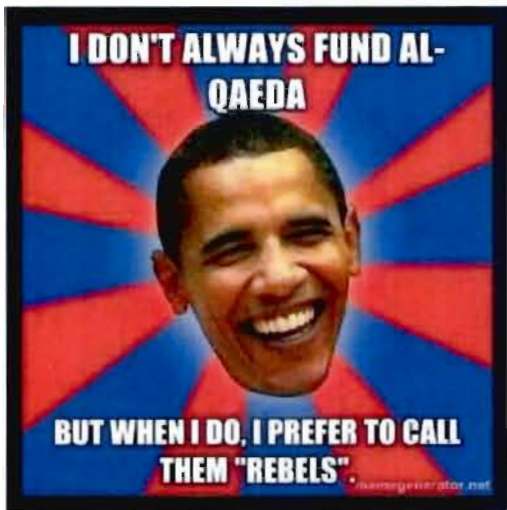
